[Alabama](#) – 2014-15 school year. This is a minimum salary schedule – districts must pay their teachers at least this amount.

[Arkansas](#) - 2014-15 school year. This is a minimum salary schedule – districts must pay their teachers at least this amount. This chart has a breakdown of each school district's pay scale and how it compares to the state minimum.

[Georgia](#) – 2014-15 school year.

[Hawaii](#) – 2014-15 & 2015-16 school year

[Kentucky](#) – 2014-15 school year. This is a minimum salary schedule – districts must pay their teachers at least this amount.

[North Carolina](#) – 2014-15 school year. It is possible for a district to pay more to their teachers than this scheduled amount – however that amount would have to come from local sources.

[Ohio](#) – The state has a minimum salary schedule in legislation but it has not been updated in years.

[Oklahoma](#) - 2014-15 school year. This is a minimum salary schedule – districts must pay their teachers at least this amount.

[Tennessee](#) - 2014-15 school year. It is possible for a district to pay more to their teachers than this scheduled amount – however that amount would have to come from local sources.

[Texas](#) – 2014-15 school year. This is a minimum salary schedule – districts must pay their teachers at least this amount.

[Washington](#) – 2013-14 & 2014-15 school years. The state uses this schedule to allocate state funds to districts. Districts can pay teacher more than this amount but the additional funding would have to come from state sources.

[West Virginia](#) - 2014-15 school year. This salary schedule is adjusted for each district in the states.

Other:

[Iowa](#) – The state has a minimum teacher salary of \$33,500.

[California](#): The state does not have a minimum salary schedule but it does require that school districts report their starting and average teacher pay each year. This table is for the 2013-14 school year.
